

CATTLE HERD HEALTH STATUS DECLARATION

Instruction to owners/exhibitors:

1. Complete part 1 of this form.
2. This form is not an interstate permit. However, if stock are likely to be sold or moved onwards from a show/sale part 2 should be completed by your local animal health official to assist authorities prepare the necessary official interstate movement certificates.
3. This form provides the basis for preparing documentation required by other states prior to entry of cattle. Further testing and disease certification may be required for cattle entering some states.
4. There is no provision for individual animal testing for Johne's Disease (JD) on this form.
5. This Herd Health Status form is valid for 6 months from the date of issue. The owner must notify the issuing local animal health official of any change in herd status or other information on the form subsequent to completion of this form.

THIS FORM IS NOT ACCEPTABLE AS AN ENTRY PERMIT TO OTHER STATES.

 - the cattle to be sold are not officially listed as "at risk" cattle for the particular herd; and
 - the cattle to be sold have not been tested negative within 3 months of the date of the sale.

Exhibitors may also need additional certification to move between Zones or between States. Check with your local veterinary authority. The above information, including the description of the animals and property/ies of origin is complete, true and correct.
